Site 3 (101-127)

#### Lettings

There has been a low turnover over plots this year. Of the 6 plots let, 2 plot holders had to give up their plots because their personal circumstances did not allow them sufficient time. Despite being very clear about the time commitment required, it seems that a number of potential plot holders do not have realistic expectations about the amount of work involved in looking after an allotment. With Jackie Savage, the waiting list co ordinator, site secretaries are working to strengthen the information given to those on the waiting list in the hope that applicants will be clearer about how they can balance looking after an allotment with other commitments in their lives.

For those who have been on the waiting list for a long time, they are often keen to avoid losing their place in the queue. Their circumstances have often changed since their original application. Those in this situation are offered a place on the secondary waiting list. When they feel ready to take on an allotment they can contact Jackie who will prioritise their application on the primary list as vacancies arise.

#### **Site Inspections**

These are an important part of the management of the allotments. Feedback from visitors to the sites over the last year show how impressed they are with the general care and attention that plot holders give to their plots.

I recognise that some plot holders may feel a bit intimidated by the prospect of inspections. This is not our intention. Maintaining basic standards benefits all plot holders. Where there are difficulties in achieving these, site secretaries aim to be supportive and helpful rather than punitive. Most of the replies I receive to concerns appreciate this.

I continue to be concerned about the state of some of the paths in the inner part of site 3 due to their narrowness and uneven surfaces. This is made worse in some places by plants growing over the boundary of a plot onto the path and causing an obstruction. This is the main reason for my writing to a plot holder after an inspection.

Walking around the plots three times a year also gives me an opportunity to see how well most plot holders look after their allotment. The variety of planting and imagination people bring to the site is quite inspiring and I welcome such diversity.

#### The Committee

In my relatively short relationship with RGS I have been so impressed with the work of the Committee under the leadership of Helen. I appreciate the support she, and other committee members, have given me during the last year.
